

Raffles University situated in NCR at Neemrana, on Delhi-Jaipur National Highway No. 48, is just 90 km away from Delhi International Airport and is also connected by a six-lane expressway and by the railway line at Rewari Junction. The distance from Jaipur is 140 Kms.

The state-of-the-art infrastructure with all modern facilities, built on a sprawling 50 acres of land, is set in an unpolluted serene environment in the lap of Aravalli hills. The University is based on the "GURUKULA" concept whereby the students move away from the rough and tumble of stressful existence to the quieter environment of the University in Neemrana. This ambiance, enables a strong bond between teacher and pupil ensuring thereby greater attention to instruction as well as education free of distraction and impediments.
